Please read all of this leaflet carefully before taking this medicine, it contains important information.

Please keep this leaflet; you might need to read it again.

1. What is this medicine for

Pollenna is a homeopathic medicinal product used within the homeopathic tradition for the symptomatic relief of hay fever and other symptoms of allergic rhinitis, such as sneezing, itchy eyes, blocked or runny nose.

2. Before taking this medicine

- Do not take this medicine if you are under 12 years old.
- Do not take this medicine if you are allergic to any of the ingredients, see section 6.
- This product contains lactose and sucrose. If you have been told by your doctor that you have an intolerance to some sugars, consult your doctor before taking this medicine.
- Talk to your doctor or pharmacist before taking this medicine if you are:
 - taking any other medicines, including those bought without a prescription.
 - pregnant or breastfeeding.

3. How to use this medicine

For oral use

For adults, the elderly and children over 12 years:

Directions

Take 2 tablets every 2 hours for the first 6 doses on the first day, then the following day take 2 tablets 3 times a day until symptoms improve for up to a maximum of 7 days.

Tablets to be sucked or chewed and are to be taken between meals.

If symptoms worsen, or do not improve after 7 days, consult your doctor or qualified healthcare practitioner.

Do not exceed the stated dose.

If you forget to take this medicine, continue with the usual dose at the usual time. It does not matter if you have missed a dose. Do not take a double dose to make up for a missed dose.

If you take too much of this medicine speak to a doctor or pharmacist and take this leaflet with you.

4. Possible side effects

This medicine is not expected to cause any side effects. However, consult a doctor or qualified healthcare practitioner if the symptoms worsen, or persist for more than 7 days or if any side effects occur.

Reporting of side effects

If you get any side effects, talk to your doctor, pharmacist or nurse. This includes any possible side effects not listed in this leaflet.

5. How to store this medicine

- Keep all medicines out of sight and reach of children.
- Do not store above 25°C. Store in original packaging in order to protect from moisture.
- Do not use after expiry date (EXP) shown on carton and blister. This expiry date refers to the last day of that month.
- Return any unused medicine to your pharmacist for safe disposal.

Pollenna are biconvex circular white to off-white tablets.

There are 72 tablets in a pack.
