1. What is this medicine for

Noctura is a homeopathic medicinal product used within the homeopathic tradition to aid sleep and for the temporary relief of sleep disturbances.

2. Before taking this medicine

- Do not take this medicine if you are under 18 years old.
- Do not take this medicine if you are allergic to any of the ingredients, see section 6.
- This product contains lactose and sucrose. If you have been told by your doctor that you have an intolerance to some sugars, consult your doctor before taking this medicine.
- Talk to your doctor or pharmacist before taking this medicine if you are:
- taking any other medicines, including those bought without a prescription.
- pregnant or breastfeeding.
- Driving and using machines if you feel sleepy, do not drive or use machines.

3. How to use this medicine

Directions

For oral use

For adults and the elderly

Take 2 tablets 4 hours before retiring and 2 tablets immediately before retiring. A further 2 tablets may be taken during the night if required.

Tablets to be sucked or chewed.

If symptoms worsen, or persist after 7 days, consult your doctor or qualified healthcare practitioner.

Do not exceed the stated dose.

If you forget to take this medicine, continue with the usual dose at the usual time. It does not matter if you have missed a dose. Do not take a double dose to make up for a missed dose.

If you take too much of this medicine speak to a doctor or pharmacist and take this leaflet with you.

This medicine is not expected to cause any side effects. However, consult a doctor or qualified healthcare practitioner if the symptoms worsen, or persist for more than 7 days or if any side effects occur.
