Dear Wholesaler,

We wish to inform you that the above listed batches of Purevax® RCP and Purevax® RCP FeLV are being recalled with immediate effect.

This recall is going to **veterinary clinic level**. The action has been agreed with the Health Products Regulatory Authority (HPRA).

The reason for the recall is the potential presence of microcracks at the neck of some vials.

A separate recall letter is being issued to Veterinary surgeons requesting that they return impacted stock to you, their wholesaler.

### You are kindly requested to please perform the following actions:

1. Immediately identify and quarantine any units of the above batches in your possession, as well as any units returned to you by your customers.
2. If you have supplied the batch to any other wholesaler, please send them a copy of this recall letter, requesting that they quarantine and return any unsold quantities of the batch to you.
3. Please return all quarantined stock, including full or part packs, from the batch before Friday 12<sup>th</sup> April 2024 to our logistic services provider, Allphar Services Ltd, Greenogue Business Park, Rathcoole, Co Dublin, for credit.

Replacement stock of Purevax® RCP FeLV and Purevax® RCP can be provided via your pre wholesaler.
