# SINGLE INSULATION POWER CABLE

#### SCOPE

This notice pertains to the following products manufactured by BHM Medical between May 2004 and March 2006 which are equipped with an internal battery charger:

### BACKGROUND

During the assembly of some of the above mentioned products, an improper power cable was installed on the control box. This power cable is single insulated, which increases the risk of premature failure.





Fig 1: Power cable location



#### **HEALTH HAZARD ANALYSIS**

A power cable failure could result in a connection between the metal structure of the hoist and the main power. Therefore, there is a risk of electrical shock for the user while the hoist is plugged to an electrical outlet.

# **ACTIONS TO TAKE**

- 1. Make sure that you carefully read and understand the FSN and the FSN Receipt form.
- 2. Make sure that this notice (including the FSN Receipt form) is distributed to all those who need to be aware within your organization or to any other organization to which the potentially affected hoist might have been transferred.
- 3. Inspect your hoist to determine if it is equipped with the single insulated power cable. The improper power cable can be located and identified by visual inspection (refer to Fig. 1 and Fig. 2).
- 4. If your hoist is equipped with a single insulated power cable, stop using it and call your dealers/distributors for a power cable replacement.
- 5. Complete and return the attached FSN Receipt form to your dealers/distributors or to BHM Medical within 10 days following reception.

# **NEXT STEP**

The single insulated power cable will be replaced, free of charge, by our dealers/distributors.
