Urgent Field Safety Notice

Product name : Rotavirus Positive Control : Batch number 1081G1408

Type of action:

Details on affected devices:

Coris BioConcept Rotavirus positive control C-1081 (0,7 mL vial) with the lot number 1081G1408.

Description of the problem:

Rota positive control intended use is to control the functionalities of Coris Bioconcept's *in vitro* diagnostic devices Rota-Strip, Combi-Strip and Combi K-SeT, GastroVir-Strip.

The intensity of the Rotavirus test line signals generated by the incriminated Rota positive control could be judged too weak.

As a consequence, one may erroneously conclude that the tested diagnostic kit quality is beyond the expectations and that weak positive signals could be missed with clinical samples.

Advise on action to be taken by the user:

■ Evaluation of the device

Verify that the Rotavirus Positive Control meets the expectations of your laboratory considering the given signal intensities.

☐ Return the device to the supplier

If the Rotavirus test line signal intensities are considered as too weak, please discard the entire batch you may possess or return it back to Coris BioConcept or to your local distributor.

□ Acknowledge form

Please send the attached acknowledge form back to Coris BioConcept or your local distributor.
