This letter is to inform you of a Field safety notice initiated by Covidien

Description of the Problem

Light handle covers MAY contain splits or holes

Safety Action

Covidien has issued a Recall which indicates that all affected LHC's are to be removed from the market. ArcRoyal has placed the affected LHC into CPT's. ArcRoyal is issuing this Field safety notice to all their customers to provide instructions on how to control the affected LHC.

Attached is a list of all CPT's which have been supplied to you from ArcRoyal that is affected by this Field Safety Notice. Unfortunately as Covidien have temporarily ceased manufacturing the LHC they have no equivalent LHC to offer us for replacement, therefore ArcRoyal cannot offer you an equivalent sterile LHC straight away. However ArcRoyal are working to supply an equivalent sterile LHC, we will be in a position to inform you of further details in due course.

Advice on Action to be taken by the user:

To minimize disruption and ensure continuous patient care, ArcRoyal is recommending the following:

- 1. Check your inventory to identify affected CPT's
- 2. Place on Hold any CPT's that are affected
- 3. Complete the attached verification form Appendix I This should be done even if you have no affected product
- 4. Return the completed Field Safety Corrective Action Response Form Appendix I to Arcroyal (iarmstrong@arcroyal.ie)
- 5. On use of the CPT the affected Light handle cover (LHC) is to be removed
- 6. The affected Light handle cover (LHC) can be returned to ArcRoyal or destructed at the hospital
- 7. If the light handle cover (LHC) is destructed in the hospital appendix II must be completed and return to ArcRoyal
