

# **Urgent Field Safety Notice**

Olerup SSP HLA A typing kits: A\*01 Lots: 41V, 35X, 83Y A\*24 Add-on Lot 32Y

May 04; 2016

Type of action: Advice by manufacturer – review of previous results

Attention: Update of interpretation tables Olerup SSP A\*01 and A\*24 Add-on typing kits.

#### **Details on affected devices:**

In listed product/lots the kit of A\*01, the A\*01:04N allele is not amplified by primer-mix 5 as stated in product documentation. This concerns the following products: A\*01 Lots: 41V, 35X, 83Y

The primer causing the false negative reaction is also present in the kit A\*24 Add-on Lot 32Y.

### Description of the problem:

The false negative amplification for the A\*01 kit yields a revised reactivity pattern for the A\*01:04N allele that is identical to A\*01:01 alleles. The false negative amplification in the kit A\*24 add-on creates a kit that cannot separate the A\*24:11N from the A\*24:02:01G alleles $^{1}$ .

## Advise on action to be taken by the user:

## Affected A\*01 kits:

Review of interpretation of HLA-A typing results retrieved from the listed A\*01 kits/lots to identify results that include A\*01:01 alleles. Those typings should be re-typed to ensure correct HLA-type.

Customers that have made typings using the affected A\*01 kits yielding results that include A\*01:01 alleles are asked to confirm numbers to Olerup and will be provided with the corresponding number of Olerup HLA-A\*01 add-on kits for retyping. The A\*01 add-on kit specifically resolve this HLA typing ambiguity i.e. separates the A\*01 alleles from A\*01:04N allele.

## Unused affected A\*01 kits should be discarded.

The customers who have unused affected A\*01 tests/kits on the shelf, are asked to discard these and confirm numbers to Olerup SSP AB. The tests will be replaced with the corresponding number of updated A\*01 kits.

Unused affected A\*24 add-on tests should be discarded.

The customers should confirm number of discarded A\*24 add-on tests Olerup SSP AB.

All distributed A\*24 add-on tests will be replaced by the corresponding number of updated A\*24 add-on kits.
