## **Reason for Field Safety Notice**

## **Description of the problem:**

Microbial contamination was identified in two batches of manufactured W11346 Fastidious Anaerobic Agar + Horse Blood.

Contamination is evident in packs of these batches remaining on site in the agar of the plates.

This type of contamination is uniform in appearance, presenting as small white/grey colonies with darkening of the surrounding media.

## Primary clinical purpose of the device and hazard giving rise to the FSN:

W11346 Fastidious Anaerobic Agar + Horse Blood is a primary isolation medium capable of growing most clinically significant anaerobes.

Contamination of the media not observed prior to use may result in repeat testing and would lead to a delay in reporting results.

This may also result in requiring a further sample from the patient e.g., a swab would become compromised if used on contaminated media.
