
Synthes GmbH is issuing a medical device recall related to the above mentioned lot of Drill Bit Ø 2.0mm drilling depth 14mm, 3-flute, for Quick Coupling.

Our records indicate that you may have inventory or loan sets that are subject to this product recall and we kindly request you review the information below and complete the Verification Section at the end of this letter.

Description of the problem:

It was discovered that a product of the above mentioned lot of 2.0 mm Drill Bits with 14mm Stop/ Zero-P had been manufactured with a tip that was 16mm. This 16mm component was then incorrectly packaged, labeled, and distributed as a 14mm drill bit.

L2 (flute length) for non-conforming part (top) is the same as that of a 14mm Drill (Bottom), but L (Length of Drill Tip) is the same as a 16mm Drill

Potential hazard:

If the non-conforming drill bit passed unrecognized into the operation room and to the surgeon for use, the longer than intended drill bit could potentially penetrate the posterior wall of the vertebral body. This could potentially result in minor bone, soft tissue or disc damage or, in a worst-case scenario, damage to the spinal cord, meninges, or nerves with the potential for permanent injury. If a dural tear occurred intraoperatively, the necessary repair might lead to a significant lengthening of the surgery.

To date, there have been no reports of patient injury related to this issue.

Requested Immediate Customer actions:

- Immediately identify and quarantine all unused product listed below in a manner that ensures the affected product will not be used.
