DESCRIPTION

Customers are to be advised of the following:

A technical investigation has determined that specific lots of Thermo Scientific[™] Remel[™] E. coli Polyvalent Agglutinating Sera may produce weaker than expected agglutination reactions with certain serotypes when used in accordance to the Instructions For Use (IFU).

Continued use of these lots may result in failure to correctly identify specific *Escherichia coli* serotypes.

RISK TO HEALTH

We believe the clinical risk is extremely low based on the following rationale:

Patient management should not be affected by a failure to identify the correct serotype. In particular infants with apparent diarrhoea or haemolytic uremic syndrome would be treated and managed in the same way long before any serotype of *E. coli* was recovered. The risks associated with incorrect identification of *E.coli* serotypes is related primarily to epidemiology specifically that a suspected outbreak might not be linked correctly. There has been a move to use specific chromogens to identify probable serotypes associated with Shiga-like *E. coli* infections and serotyping of *E. coli* may well be superseded by more rapid ways of identifying specific pathogenic types.

Action To Be Taken

Our records indicate that you have received the above product. Accordingly, in keeping with our Quality Policy, we request that you destroy any remaining inventory of E. coli Polyvalent Agglutinating Sera (R30954901), lots as indicated in the table.
