## **DESCRIPTION OF THE PROBLEM:**

This Field Safety Notice (FSN) is to inform you of a voluntary worldwide product recall involving specific lots of Comfort Shield Barrier Cream Cloths. The recalled products were distributed between August 2014 and August 2016. This FSN is being initiated due to potential product contamination with *Burkholderia cepacia*. See identified lots below.

If you have any of the above listed products, please do not use or distribute. Please ensure that this notice will be given to all those who need to be aware of it within your organization and/or other organizations you may have given this product to.

- 1. Check your inventory for the affected lot numbers. Lot numbers are located on the outside of the product case (over shipper). Discontinue use and/or further distribution of the affected lots. Quarantine all identified lots.
- 2. If you are a distributor and have distributed this product to facilities or consumers, please initiate your sub-recall process down to the facility or consumer level.
- 3. If you are a healthcare facility, stop use of the affected lots of product immediately.
- 4. Please complete the Field Safety Notice (FSN) Acknowledgment Response and return it to Sage Products no later than September 19, 2016. This form must be completed even if you do not have any of the affected product.
- 5. After the FSN Acknowledgment Response form is received by Sage, you will be contacted regarding how to proceed with the return/destruction of the identified lots.

Please maintain awareness of this Notice and resulting action for an appropriate period of time to ensure effectiveness of the corrective action.
