## Identification of affected medical devices:

Lifting Table Diagnostic 1171, used as optional accessory for the WaveLight diagnostic systems ALLEGRO Analyzer, ALLEGRO Topolyzer und ALLEGRO Oculyzer. Serial numbers 0001 to 0306.

# Description of the problem, including the identified root cause:

During a re-evaluation of the design of the lifting table by a third party testing laboratory various deviations in relation to the standard EN SIO 60601-1 were detected, although the lifting table was labelled as conform to EN ISO 60601-1.

The manufacturer of the Lifting Table, Ergo-Tec GmbH, has evaluated the risks resulting from the deviations from the standard EN ISO 60601-1. According to this risk evaluation none of the deviations pose an immediate hazard for health, safety or effectiveness of the table, or influence the effectiveness of the Lifting Table or the mounted WaveLight diagnostic devices

Most of the deviations concern the user comfort or the labelling of the table, and were evaluated as low risk. Some of the deviations represent a potentially increased risk.

In these cases there is no immediate hazard for the user, a risk could only arise as a consequence of an already present defect of the table (e.g. a damaged cable insulation). A modification of the tables during the next service visit was deemed as sufficient.

## Which measures must be taken by the recipient?

The recipient must not take any measures. The WaveLight diagnostic devices and the corresponding Lifting Table can be used without restrictions according to the user manual.

Your service partner for the Lifting Table Diagnostic will perform the required corrections of the Lifting Table Diagnostic 1171 during the next regular service visit.
