## 1. What is this medicine for

Travella is a homeopathic medicinal product used within the homeopathic tradition for the relief of symptoms of travel sickness, such as nausea, vomiting, dizziness and headache.

# 2. Before taking this medicine

- Do not take this medicine if you are under 12 years old.
- Do not take this medicine if you are allergic to any of the ingredients, see section 6.
- This product contains lactose and sucrose. If you have been told by your doctor that you have an intolerance to some sugars, consult your doctor before taking this medicine.
- Talk to your doctor or pharmacist before taking this medicine if you are:
- taking any other medicines, including those bought without a prescription.
- pregnant or breastfeeding.

## 3. How to use this medicine

#### For oral use

Take 2 tablets every hour for 2 hours before the journey. Take 2 tablets hourly during the journey if necessary.

Tablets to be sucked or chewed.

If symptoms worsen, or persist after 5 days, consult your doctor or qualified healthcare practitioner.

Do not exceed the stated dose.

**If you forget to take this medicine,** continue with the usual dose at the usual time. It does not matter if you have missed a dose. Do not take a double dose to make up for a missed dose.

**If you take too much of this medicine** speak to a doctor or pharmacist and take this leaflet with you.

#### 4. Possible side effects

This medicine is not expected to cause any side effects. However, consult a doctor or qualified healthcare practitioner if the symptoms worsen, or persist for more than 5 days or if any side effects occur.
