1 NAME OF THE MEDICINAL PRODUCT

Cozaar Comp 100mg/25mg Film-coated Tablets

2 QUALITATIVE AND QUANTITATIVE COMPOSITION

Each tablet contains 100mg of losartan potassium and 25mg of hydrochlorothiazide (HCTZ) as the active ingredients.

Excipient: Lactose Monohydrate
