

The oral solution is packaged in a 100 ml amber glass bottle with a child-resistant closure and a pipette, calibrated in millilitres. The pipette has a minimum volume of 0.5 ml and a maximum volume of 4 ml.

6.6 Special precautions for disposal and other handling



To open the bottle and use the pipette:

- Fig. 1: The bottle comes with a child-resistant cap, and should be opened as follows:
- Push the plastic screw cap down while turning it counter clockwise.

- Remove the unscrewed cap.

Fig. 2: Insert the pipette into the bottle.

While holding the bottom ring, pull the top ring up to the mark corresponding to the number of millilitres you need to give.

Fig. 3: Holding the bottom ring, remove the entire pipette from the bottle. Empty the pipette into any non-alcoholic drink by sliding the upper ring down and drink it immediately. Close the bottle. Rinse the pipette with some water.
