3 PHARMACEUTICAL FORM

An insecticidal clear solution presented in an aerosol spray.

4 CLINICAL PARTICULARS

4.1 Target Species

Dogs and cats.

4.2 Indications for use, specifying the target species

For the topical treatment of flea infestation on cats and dogs for up to 15 days. The product has some efficacy against the flea egg and larval stages.

4.3 Contraindications

Do not use in animals with known hypersensitivity to the active ingredient. Do not use on puppies or kittens under 12 weeks of age or on nursing bitches and queens.

4.4 Special warnings for each target species

Sick and convalescing animals must be treated by a veterinary surgeon. Not for use on puppies or kittens under 12 weeks of age or on nursing bitches and queens. Remove fleas from young puppies, kittens, nursing bitches and queens by careful use of a comb.

4.5 Special precautions for use

Special precautions for use in animals

Dangerous to fish and aquatic vertebrates. Do not contaminate fish bowls, aquaria etc..

Special precautions to be taken by the person administering the veterinary medicinal product to animals

Wash hands and exposed skin after use.

Avoid inhaling spray mist.

Keep away from food or drink.

4.6 Adverse reactions (frequency and seriousness)

None.

4.7 Use during pregnancy, lactation or lay

Do not use in nursing bitches or queens.

4.8 Interaction with other medicinal products and other forms of interaction

None.

4.9 Amounts to be administered and administration route

For topical administration.

Apply the spray evenly to the animal against the natural lie of the coat. Use the aerosol at a distance of 15-20 cms (6-8 inches). The recommended spraying time is:

The recommended spraying time is:

DOGS:Spray for 3-5 seconds on a small dog (e.g. terrier).Spray for 10 secondson a mediumsized dog (e.g. collie).Spray for 15 seconds on a large dog (e.g. alsatian).on a medium

CATS: Spray for up to 3 seconds depending on the size of the cat.

Protection against reinfestation is usually retained for up to 15 days. Treatment may be repeated after 15 days if any reinfestation is apparent.

4.10 Overdose (symptoms, emergency procedures, antidotes), if necessary

Treatment of the animal should not exceed once per 15 days.

4.11 Withdrawal Period(s)

Not applicable.

Insecticidal solutions.
