## Information

**Read all of this leaflet carefully before you start taking this product because it contains important information for you.**

Always take this product exactly as described in this leaflet or as your doctor, pharmacist or nurse has told you.

- Keep this leaflet. You may need to read it again.
- Ask your pharmacist if you need more information or advice.
- If you get any side effects, talk to your doctor, pharmacist or nurse. This includes any possible side effects not listed in this leaflet. See section 4.
- You must talk to a doctor if you do not feel better or if you feel worse after 3 months.

## 1. What Agnus castus is and what it is used for

Agnus castus is a traditional herbal medicinal product containing the extract of Agnus castus fruit.

It is used to relieve the minor symptoms of **premenstrual syndrome**. This is exclusively based on long-standing use.

Agnus castus is for use in women over 18 years of age.

Premenstrual syndrome (PMS) consists of the symptoms that can occur in the two weeks before a monthly period. It is also known as premenstrual tension (PMT). Symptoms can be both physical and emotional and can include irritability, mood swings, breast tenderness, bloating and menstrual cramps.

## Do's and Don'ts for taking Agnus castus

### 2. What you need to know before you take Agnus castus

#### Do not take Agnus castus

- If you are allergic to any of the ingredients of this product (listed in section 6).
- If you have a pituitary disorder.
- If you are pregnant, trying to become pregnant or breast-feeding.

#### Warnings and precautions

- Talk to your doctor **before** taking this product if:
  - You suffer from or have suffered from an oestrogen-sensitive cancer
  - You have suffered from a pituitary disorder
- Talk to your doctor or pharmacist if your symptoms worsen or do not improve after taking this product for 3 months.

#### Children and adolescents

- Do not give this product to children or adolescents under 18 years of age.

#### Other medicines and Agnus castus

- Do not take this product if you are already taking another medicine which is affected by alcohol.
- Talk to your doctor **before** taking this product if you are taking any of the following medicines:
  - Dopamine agonists
  - Dopamine antagonists
  - Oestrogens
  - Antioestrogens
- If you are speaking to your doctor, pharmacist or nurse always remember to tell them about any medicines you are taking, including herbal remedies such as Agnus castus.

#### Pregnancy and breast-feeding

- Do not take this product if you are pregnant, trying to become pregnant or breast-feeding.

#### Driving and using machines

- This product contains alcohol (see below for alcohol content). Overdose of this product may result in alcohol intoxication.

#### Agnus castus contains alcohol

- This medicinal product contains 69.5 vol % ethanol (alcohol), i.e. up to 336 mg per 20 drop dose, equivalent to 8.4 ml beer (around half a tablespoon) or 3.5 ml wine (less than a teaspoon) per dose.
- Harmful for those suffering from alcoholism.
- To be taken into account in pregnant or breast-feeding women, children and high-risk groups such as patients with liver disease, or epilepsy.

## Using

### 3. How to take Agnus castus

Always take this product exactly as described in this leaflet or as your doctor, pharmacist or nurse has told you. Check with your doctor, pharmacist or nurse if you are not sure.

#### Recommended dose

##### Women experiencing minor premenstrual symptoms:

Take 15-20 drops in a little water twice daily.

The effects of this product may not be felt immediately. For best results you may need to take this product for up to 3 months.

For oral use only. Do not take more than the recommended dose.

##### If you take more Agnus castus than you should

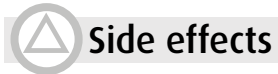
- If you take too much and feel ill, talk to your doctor.
- Overdose of this product may result in alcohol intoxication.

### If you forget to take Agnus castus

- Do not worry about a missed dose. Take the next dose as usual.
- Do not take a double dose to make up for a forgotten dose.

If you have any further questions on the use of this product ask your doctor, pharmacist or nurse.



## Side effects

### 4. Possible side effects

Like all products, this product can cause side effects, although not everybody gets them.

#### Side effects

##### Allergic reactions

- Swelling of the face, breathlessness and difficulty swallowing

Stop taking the product immediately if these occur. Seek medical advice and take this leaflet with you.

##### Skin reactions

- Rash
- Red, itchy spots (urticaria)

Stop taking the product if these occur.

##### Other reactions

- Headache
- Dizziness
- Digestive upsets such as feeling sick or stomach pain
- Acne
- Menstrual disorders

These are often short-lived and should go away by themselves. However if they persist, talk to your doctor, pharmacist or nurse.

The frequency of the above side effects is not known. This means that it is not known how often these reactions occur as there have not been enough reports to allow this information to be calculated.

- If you get any side effects, talk to your doctor, pharmacist or nurse. This includes any possible side effects not listed in this leaflet.

## Information

### 5. How to store Agnus castus

- Keep this product out of the sight and reach of children.
- Do not use this product after the expiry date which is stated on the label and carton. The expiry date refers to the last day of that month.
- This product does not require any special storage conditions.
- Do not use this product if you notice a change in appearance. It should be a clear liquid that is yellow-brown in colour.
- Do not throw away any medicines via wastewater or household waste. Ask your pharmacist how to throw away medicines you no longer use. These measures will help protect the environment.

### 6. Contents of the pack and other information

#### What Agnus castus contains

One dose (15-20 drops) contains 407-542 mg of tincture from Agnus castus fruits (*Vitex agnus-castus* L.) (1:10). Extraction solvent: Ethanol 69.5% V/V.

The other ingredients used for the liquid are ethanol and water.

### What Agnus castus looks like and contents of the pack

Agnus castus is a clear liquid that is yellow-brown in colour. Agnus castus is available in 50 ml brown glass bottles.
