It is used to relieve muscular aches and pains. This is exclusively based on long-standing use.

Used to help relieve symptoms including:

- Muscular aches, pains and stiffness
- Sprains
- Bruises
- Swelling after injury

Atrogel is for use in adults and children.

Do not use Atrogel

- If you are allergic to:
 - Arnica or plants of the daisy (Asteraceae/Compositae) family. Arnica is a member of the daisy family.
 - Products containing Arnica.
 - Any of the other ingredients of this product (listed in section 6).

Warnings and precautions

- Do not use on broken, cut or irritated skin. This product may cause irritation.
- Do not use in or near your eyes, nose, mouth or other sensitive areas. This product may cause irritation.
- Do not use at more than the recommended dose.
- Talk to your doctor or pharmacist if your symptoms worsen or do not improve within 1 week.

Other medicines and Atrogel

- You can use this product with other medicines.
- If you are speaking to your doctor, pharmacist or nurse always remember to tell them about any medicines you are taking, including herbal remedies such as Atrogel.

3. How to use Atrogel

Recommended dose

Adults: Apply 2 - 10 cm of gel gently to the affected area. Use 2 to 4 times a day.

Children and older people: Follow the adult dose.

The amount of gel to be applied depends on the size of the area of injury.

For cutaneous use only. This means you can use this product on your skin but not in or near your eyes, nose, mouth or other sensitive areas. Do not apply if your skin surface is broken, cut or irritated.

When first opening the tube check that the seal is not broken. Remove seal before use.

If you use more Atrogel than you should

- Your skin may become red or irritated. If this happens stop using this product.

If you swallow Atrogel by mistake

- Seek medical advice immediately and take this leaflet with you.

If you forget to use Atrogel

- Do not worry about a missed dose. Apply the next dose as usual.
- Do not apply a double dose to make up for a forgotten dose.

- Replace cap after use.
- Keep this product out of the sight and reach of children.
- Do not use this product after the expiry date which is stated on the carton and tube after EXP. The expiry date refers to the last day of that month.
- This medicinal product does not require any special storage conditions.
- Do not use this product if you notice a change in appearance. It should be a slightly cloudy gel that is golden-brown to yellowy-green in colour.
- Do not throw away any medicines via wastewater or household waste. Ask your pharmacist how to throw away medicines you no longer use. These measures will help protect the environment.

6. Contents of the pack and other information

What Atrogel contains

1 g of gel contains 500 mg of tincture from fresh *Arnica montana* L., flos (Arnica flower) equivalent to 120 - 200 mg of fresh Arnica flowers. Extraction solvent: Ethanol 50% m/m.

The other ingredients are ethanol, purified water, glycerol and ammonium acryloyldimethyltaurate/VP copolymer.

What Atrogel looks like and contents of the pack

Atrogel is a slightly cloudy gel that is golden-brown to yellowy-green in colour. Atrogel is available in 50 ml and 100 ml white plastic tubes. Not all pack sizes may be marketed.

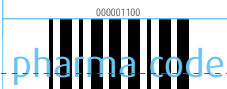

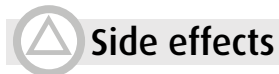
